**Copyright Policy for FAME.IAM** 

Effective Date: 11/20/2024

FAME.IAM ("the App") is committed to respecting the intellectual property rights of others and expects its users to do the same. This Copyright Policy outlines your rights and responsibilities related to uploading, sharing, live streaming, and using content within the App.

1. Ownership of Uploaded Content

By uploading or sharing videos, music, audio, or other content ("User Content") on the App, you confirm that:

- You own the copyright or have the necessary licenses, rights, consents, or permissions to share the content.
- You grant FAME.IAM a non-exclusive, worldwide, royalty-free license to host, store, distribute, display, reproduce, and modify your content solely for operating and promoting the App.

2. Using Other Users' Music or Audio

- Users may incorporate audio or music from other users into their own videos provided that:
- The original creator grants explicit permission or has licensed the audio for reuse within the App.
- Any reuse complies with applicable copyright laws and this policy.

FAME.IAM provides tools to attribute audio and music to their rightful creators when reused. Failure to provide proper attribution may result in content removal or suspension of account privileges.

## 3. Prohibited Activities

You may not upload, share, or use content that:

- Infringes upon the copyright, trademark, or other intellectual property rights of others.
- Contains copyrighted music, video, or audio that you do not own or lack proper authorization to use.
- Violates any applicable laws or regulations.

# 4. Reporting Copyright Infringement

If you believe that content shared on the App infringes your copyright, you may submit a Copyright Infringement Notice by contacting us at:

#### Your notice must include:

- a. A description of the copyrighted work you claim is infringed.
- b. The URL or description of the allegedly infringing content.
- c. Your contact information (email, phone, mailing address).
- d. A statement under penalty of perjury that you have a good-faith belief that the use of the material is not authorized by the copyright owner, its agent, or the law.
- e. Your physical or electronic signature.

#### 5. Counter-Notification

If your content has been removed due to a copyright claim, you may submit a Counter-Notification to dispute the claim by contacting us at the same email or address. Your Counter-Notification must include:

- a. Identification of the removed content and its location before removal.
- b. A statement under penalty of perjury that you have a good-faith belief the content was removed due to a mistake or misidentification.
- c. Your contact information.
- d. Your consent to jurisdiction in your location or [Insert Jurisdiction, and acceptance of service of process from the claimant.
- e. Your physical or electronic signature.

### 6. Repeat Infringers

Users who repeatedly violate this policy or upload infringing content may have their accounts suspended or terminated in accordance with our Terms of Service.

# 7. Licensing for Live Streaming and User Interaction

- Content shared during live streaming must comply with copyright laws. Users are prohibited from live streaming copyrighted material they do not own or have permission to share.
- For audio or music incorporated into live streams, ensure the material is either original or properly licensed for use.

## 8. Disclaimer

FAME.IAM does not actively monitor all content uploaded to the App. However, we reserve the right to review, remove, or disable access to content that violates this policy or applicable laws.
